

## Summary of Changes 2022 CRDTS Dental Examinations

CRDTS Dental Examination results are accepted in over 40 US states. Please see www.crdts.org for further details.

CRDTS always recommends candidates check with the appropriate State Board to verify licensure requirements for the state in question, to include specific procedures (for example, Class III, Manikin, Class II Slots).

## Manikin (Simulated Patient)-Based Examinations

- 1. CRDTS will now provide reduction matrices for Part III Fixed Prosthodontics.
- 2. A 15-minute timed Extra/Intra Oral Assessment OSCE written exam has been added as a component of the Periodontal Simulated Patient exam.
- 3. In the Periodontal Simulated Patient exam, the scoring content has been changed to remove supra-gingival calculus and stain and add 12 sub-gingival calculus detection sites.
- 4. Modification requests have been removed from the Restorative Simulated Patient-Based exam.

## **Patient-Based Examinations**

- PLEASE NOTE: For all CRDTS DENTAL EXAMINATIONS Part IV Periodontal Procedures and Part V Restorative Procedures, if the candidate does NOT violate the Open Schedule Format deadlines (please see current Dental Candidate Manual at www.crdts.org), a missing/no show Treatment Selection/Patient DOES NOT result in a failure. - 2. CRDTS continues to maintain a flexible approach to testing for specific skill sets.
  - a. Upon review of submitted, specific parameters, CRDTS will allow candidates/practitioners to challenge specific parts/procedures of our examinations as required by licensing State Boards.
    - i. EX: Original licensure examination results DO NOT include the Periodontal OR Prosthodontic procedures. CRDTS allows candidates to challenge a specific, isolated Exam Part in order to achieve licensure according to pertinent State Board requirements.
    - ii. If only 1 restorative procedure is required for licensure, candidates can opt to test on only that procedure. Time limitations will apply.
- 3. For the **2022 Dental Examination Season Part V: Restorative Procedures:** candidates failing the 2<sup>nd</sup> Restorative Patient-Based procedure will only be required to retake that particular procedure.
  - a. EXAMPLE: Candidate completes the Class II Composite Preparation/Restoration and does not receive notification of any Critical Deficiencies or Critical Errors. However, they receive notification of a corroborated Critical Deficiency or Critical Error for the Class III Composite Preparation/Restoration. Upon application and approval for a retake of the failed procedure, they will **ONLY** be required to retake that procedure. If the 1st Restorative Procedure is failed, the candidate will be stopped and must retake both procedures. However, time limitations will be in place for the retake attempt of the Class III Preparation/Restoration in the above example.
